

POWER OF ATTORNEY
For Acting on Behalf of a Minor

This power of attorney entitles one of the guardians to sign necessary agreements alone and to handle orders and money transactions on behalf of the Assignor in dealing with the Evli Group (Evli Bank Plc and Evli Fund Management Ltd), as set out in greater detail below.

Regardless of the authorization given, the Assignor is always entitled to receive information about a minor's banking matters and Evli Bank is obliged to provide this information upon request.
