This document provides key investor information on the investment product. It is not marketing material. This information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

WHAT IS THIS PRODUCT?

Туре

The Fund is a mutual fund compliant with the UCITS Directive and invests primarily in euro-denominated bonds issued by European companies and banks.

Investment term

The fund has no maturity date. The recommended holding period is at least 4 years. In principle, fund units may be subscribed for and redeemed on every Finnish banking day. The Management Company may, at its discretion, decide to dissolve or merge the Fund or its unit series. The Management Company has the right to redeem a unit-holder's units on its own initiative in the exceptional circumstances described in the Fund's rules.

Objectives

- The Fund's objective is to make sustainable investments in a way that achieves a positive and measurable social and environmental impact. The
 Fund invests in assets that, based on a sustainability analysis, are expected to have a positive impact on the environment or society or on the
 achievement of the UN Sustainable Development Goals. These assets include green bonds. In addition, the Fund's target is to exceed the return of
 the benchmark index.
- The investments will be made in bonds with both higher (investment grade) and lower (high yield) credit ratings. The average credit rating of the investments will be at least BBB- or a rating with a corresponding risk level. Moreover, a maximum of 20 percent of the Fund's assets may be invested in investments with no official credit rating. The credit risk arising from individual issuers is reduced by diversifying the investments among dozens of different issuers. The average repayment term (duration) of the Fund's fixed income investments is typically 3–7 years. Variations in the pricing of the credit risk or general interest rate level affect the Fund's performance more than is the case with money market funds. The Fund may invest its assets in derivatives contracts for hedging purposes and within the Fund's investment strategy. The Fund hedges the currency risk associated with non-euro-denominated investments at the time of making the investments.
- The benchmark of the fund's return is the Bloomberg Barclays MSCI Euro Corporate Green Bond 5% Capped Index. The fund's investment style is active and the fund does not follow the benchmark index in its investment operations. The fund's performance may deviate from the performance of the benchmark index due to active portfolio management and the duration of the investment instruments may diverge from the benchmark index by +/-3 years. The fund's base currency is the euro. Minimum of 3% of the net asset value of a fund unit will be distributed annually as dividends.

Intended retail investor

The Fund suits private investors who want to invest in a diversified manner in European lower risk (investment grade) and higher risk (high yield) corporate bonds and are seeking returns higher than those of government bonds and want to use their investments to support projects that are beneficial to the environment and the attainment of sustainable development goals. Investors must have a sufficient understanding of the fund's investments and be prepared to bear the potential financial risk associated with the investment. The fund is not suitable as a short-term investment and the investment horizon should be at least 4 years.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?





The risk indicator assumes that the investor will hold the product for at least 4 years.

The overall risk indicator expresses the level of risk of this product compared to other products. It indicates how likely the product is to lose money because of market events or because the product developer is unable to pay the investor. On a scale from 1 to 7, the risk category of the product is defined as 2, which is low risk class. Potential future losses are rated at low, and poor market conditions very unlikely to affect the ability of the management company to pay the investor. The risks that the risk indicator may not necessarily fully take into account are i) liquidity risk, and ii) operational and counterparty risks associated with the use of derivatives. Be aware of currency risk. The currency of this unit series may be different from that of your country. As the investor may receive payments in the currency of this unit series and not that of the investor's country, the final return will depend on the exchange rate between these two currencies. WHAT ARE THE COSTS?

Costs over Time

Recommended holding period is at least 4 years.

The recommended holding period is based on the fund's risk-reward profile. Fund units may be redeemed on every Finnish banking day excluding those banking days on which the net asset value of the Fund or its investments cannot be determined due to foreign public or bank holidays or if the Management Company has temporarily suspended the calculation of the value of the fund units due to exceptional conditions described in the Fund rules. A list of days on which the trading of fund units is not possible is available from the Management Company and on the Management Company's website.
