### WHAT IS THIS PRODUCT?

# Type

The Fund is a mutual fund compliant with the UCITS Directive and invests its assets primarily in euro-denominated bonds with a short and medium-term remaining duration issued by European companies and banks, and in other interest-bearing investments.

#### Investment term

The recommended holding period is at least 2 years. Fund units may be subscribed for and redeemed on every Finnish banking day excluding those banking days on which the net asset value of the Fund or its investments cannot be determined due to foreign public or bank holidays or if the Management Company has temporarily suspended the calculation of the value of the fund units due to exceptional conditions described in the Fund rules. A list of days on which the trading of fund units is not possible is available from the Management Company and on the Management Company's website.

### **Objectives**


- The fund's target is to exceed the return of the benchmark index. In addition to other characteristics, the fund promotes environmental and social characteristics and requires that target companies observe good governance.
- The investments will be made in bonds with both higher (investment grade) and lower (high yield) credit ratings. The investments' credit rating will be on average at least B- or a classification with a corresponding risk level, which means that the fund's investments are subject to a substantial credit risk. Moreover, a maximum of 40% of the fund's assets may be invested in investments with no official credit rating. The credit rating requirements will not be applied to money market investments with a duration of less than a year or to commercial papers. The credit risk arising from individual issuers is reduced by diversifying the investments among dozens of different issuers. The average interest rate risk (modified duration) of the fund's fixed income investments may be no more than 2.5 years, and for individual investments, the remaining repayment term to the final due date no more than 8 years. Variations in the pricing of the credit risk or the general interest rate level affect the fund's performance more than is the case with money market funds. The fund may also invest its assets in derivatives contracts, both for hedging purposes and within the fund's investment strategy. The duration of interest rate derivatives may exceed 2.5 years. The fund hedges the currency risk associated with non euro-denominated investments at the time of making the investments.

### Intended retail investor

The Fund suits private investors i) who wish to get a better return than the traditional money market funds or bank deposits can offer, ii) who wish to get an actively managed and well diversified fixed income portfolio in a single product, iii) who wish to invest their assets without high credit risk, and iv) who want to invest responsibly and take into account not only economic analysis but also environmental, social and good governance (ESG) factors. Investors must have a sufficient understanding of the fund's investments and be prepared to bear the potential financial risk associated with the investment. The fund is not suitable as a short-term investment and the investment horizon should be at least 2 years.

# WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The overall risk indicator expresses the level of risk of this product compared to other products. It indicates how likely the product is to lose money because of market events or because the product developer is unable to pay the investor. On a scale from 1 to 7, the risk category of the product is defined as 2, which is low risk class. Potential future losses are rated at low, and poor market conditions very unlikely to affect the ability of the management company to pay the investor. The risks that the risk indicator may not necessarily fully take into account are i) liquidity risk, that is, the risk that the Fund's investment instrument cannot be sold or bought in the planned time or at the desired price, ii) credit risk, that is, the uncertainty regarding the bond issuer's ability to repay, and iii) derivatives risk, that is, the use of derivatives to obtain additional returns may increase the fund's risk and return expectation. The use of derivatives for hedging purposes or for risk management may reduce risk and return expectation. The use of derivatives may increase counterparty risk and operational risk.

Be aware of currency risk. The currency of this unit series may be different from that of your country. As the investor may receive payments in the currency of this unit series and not that of the investor's country, the final return will depend on the exchange rate between these two currencies. This risk is not considered in the indicator shown above.

This product does not include capital protection against market risk nor capital guarantee against credit risk. This product is not secured against future market developments, which means that you may lose part or all of the investment. If you cannot be paid, you may lose the entire investment.

#### Performance Scenarios

The presented figures include all costs related to the product, but do not necessarily include all costs paid by you to an advisor or distributor. The figures do not take into account your personal tax situation, which may also affect the returns you receive.

# WHAT HAPPENS IF EVLI FUND MANAGEMENT COMPANY LTD IS UNABLE TO PAY OUT?

### WHAT ARE THE COSTS?

Persons who sell or advise on this product to you may charge you for other costs. In this case, the person in question will provide you with information on the relevant costs and will show the impact all costs will have on the investment over time.

#### Costs over Time

The tables show the sums used from the investment to cover diverse types of costs. These sums depend on the amount of the investment and how long the product is held. The amounts shown here are illustrations based on an example investment amount and different investment periods. The assumption is that

- In the first year you would get back the amount invested (0 % annual return). For the other holding periods the assumption is that the product performs as shown in the moderate scenario.
